**Location:** This well kept farm is located approximately 3.5 miles South of Lingle, Wyoming on Wyoming highway 156. Lingle is a smaller town with a larger Agricultural equipment dealer and a variety of smaller businesses. Torrington is 10 miles East of Lingle and is the county seat of Goshen County the largest Ag producing county in the State of Wyoming. Torrington is the home of Eastern Wyoming College a Junior College hosting a variety of programs to fit the needs of all students. Torrington has the largest livestock auction in the State of Wyoming as well as, western Nebraska.

Torrington has a population of over 6,000 residents with all types of ag related businesses as well as an adequate number of shopping and dining establishments.

**Farmland:** The farm consists of 116.25 Deeded Acres with 82 Acres under pivot and approximately 12 Acres of flood irrigated and the balance is in native rangeland that is not fenced. Currently the pivot irrigated land and the flood irrigated land is planted to Sunflowers for the 2020 crop year. The farmland is currently leased for the 2020 crop season to a tenant farm on a cash lease. Purchase of this farm is subject to the current lease which ends at the end of the 2020 crop year. An attached soils map indicates that the soils are capable of raising all types of irrigated crops that are normally grown in the surrounding area.



**Improvements:** This beautiful four bedroom home is in great condition. The main level features a new kitchen with new appliances and a new dining room. On the main level there are two bedroom, full bath, a sunken living room with a beautiful brick fireplace. A laundry room is on the main floor for convenience. The lower level features a large family room, two bedrooms and a three quarter bath. There are three bucking horse lights on the main level that are not included in the sale of this property.

The 40x80 metal building has a partial cement floor.
